Selecting a Primary Care Provider



Use for clients who choose Greater Good Health as their selected Primary Care Provider (PCP) this Annual Enrollment Period (AEP)

Why It Matters

If your client chooses Greater Good Health as their PCP, the selection must be made during plan enrollment during AEP. We've included a quick guide below for brokers to reference when needed.

How to Write in a PCP During the Enrollment Process

Step-by-Step:

- **During Plan Enrollment (via platform or paper)**
Look for the section labeled "Primary Care Provider," "PCP Name," or "Provider Selection."
- **Enter Provider Name**
Greater Good Health
- **Enter the NPI (National Provider Identifier)**
Use the correct NPI based on your client's clinic location (See NPI information below)
- **Confirm Clinic Location (if required)**
Include the preferred city or clinic address for added clarity
- **Submit as usual**
Once processed, Greater Good Health will show as the client's designated PCP, and we'll initiate patient outreach.
